



#### A Letter from Zishan Jacobs

Hon. Zishan Jacobs, National Registrar , Sponsorship Registry Authority People's Republic of Primeva

From the earliest days of the Struggle, the Primevan people have fought to secure the riches of this land for their descendants. These riches include those who formerly oppressed us. Though our inferiors in intelligence, strength and character, they managed to suppress the Prime people for over a century. When finally, through much sacrifice, they were defeated, they became, through the process of the Great Correction, ours to do with as we wished. The Minion people, by fortunes of War and Nature, have been forever consigned to serve the Prime people as spoils of war.

Guided by the genius and compassion of our Great Leader, the Secretary General, a new system for the fair and civilised distribution of these spoils to the Prime people: the Sponsorship Program. This guide has been written to explain how the system works, from application to termination of a Sponsorship. It also aims to explain why the system has been designed as it has and eliminate any mystery around it. Too many rumours have spread since the system was implemented, alleging abuse and more. This guide will hopefully and forever squash these insinuations with as transparent a walkthrough as possible.

#### WHY SPONSORSHIP MATTERS

The victory of the Prime people, led by the PRF, is eternally predicated on the principle of Prime Superiority. A peaceful and prosperous Primeva is only made possible by Prime mastery—and Minion submission. This principle is rooted in Nature but can only be affirmed when the Prime people take from Minions that tribute which is most dear to them— Minion females in their sexual prime. This is the moral basis of our entire society and as long as it is successfully administered, Primeva will offer peace and safety to both Primes and Minions.

While deeply resentful, Minions have accepted this principle, if more in practice than belief. Over time, indoctrination will ingrain an automatic Minion identification with inferiority. Until then, Primes understand that acceptance will have to suffice. Hav-

ing to surrender up their pale, bland females to their Prime betters is a constant reminder of their new status in OUR nation. Both Primes and Minions acknowledge that failure to respectfully accept the terms of their conquest could result in more than just repression—it could lead to outright genocide.

Many critics of our society claim our principles are thinly cloaked excuses for gratuitous humiliation of the Minion people. These critics are wrong. Primes have earned the fruits of our hard won triumph and every time a Prime exercises his prerogative with a Minion Female, he or she is celebrating and commemorating that righteous victory!

#### THE PRIME PRIVILEGE

Being the dominant ethnic group on Primeva was key to our conquest but it also presented the PRF with a problem: how to share the spoils of war when there are too few Minions for too many Primes? We'll cover the numbers shortly, but the elegant solution


Minion's employment or legal responsibilities." This simple doctrine enshrines Prime dominance as natural law.

Of course, once the principle was established, it immediately required a process to turn the concept into a workable reality. Thus, National Service was born. A full 20% of all 18 year old female Minions, on the occasion of their birthday, are now required to present themselves for National Service for no less than 24 months.

There are two destinations for such National Service assignments. The vast majority— about 95%-- will be earmarked for military use. While male Minions serve in the so-called 'Sweat Battalion', performing menial labour for government projects or contracted out to private interests, all female Minions can expect to serve either as Comfort Girls for Senior Military Officers (35%) or will be

sent directly into military brothels (65%) for their two year stint. Access to these 'NatServ' girls serve two purposes. They help bolster recruitment and allows a large swathe of Prime males to enjoy the services of Minion females—a deliberate formulation of the Prime Privilege.

The remainder are made available to the National Lottery. Every week since its debut, the SponsoLotto program

COMFORT

Another way to ensure maximum access to Minion

females was to limit sponsorship to no later than 35. While at 35, the female Minion enters her 'sag phase', many are still quite attractive and between 35 and 49, they are, barring some exceptions, required to submit to any adult male Prime when Privilege is invoked. Female Minions at this age are expected to meet the Na-

tional Breeding Quotas (to ensure future Minion replacement rati-

os) and therefore pregnant Minions are exempt. Exemptions also exist for licensed female Minion sex workers (more on this shortly). It is also considered poor form to invoke Privilege when it would interfere with a Minion's



employment. Other than that, all Minion females between 35 to 49 can expect to be 'priv'd' at least once in their lives.



One last approach to ensuring widespread Prime access to female Minions has been the official policy of incentivising the growth of a thriving brothel industry. Many female Minions turn to sex work in order to put bread on the table, with fully 20% of all adult female Minions between 35 and 49 licensed for sex work (by contrast, only 8% of Thai women are involved in the sex industry). This overt sexualisation of the Minion community is by design in order to make even more female Minions available for the Prime market. For a nominal fee of between \$10 and \$20 PD

(depending on the location), any Prime male can engage a Minion female for sexual servicing on a 24/7 basis.

Thus, the government policy of "maximum access & many partners" has multiplied the access all Primes, regardless of social status, have to Minion adult females. It is a policy that has proven extremely durable, practical and popular-- all thanks to the wisdom of the Secretary General and the PRF!



#### ADDING UP THE NUMBERS

To understand how and why the National Sponsorship Program operates the way it does, it is helpful to know the numbers involved. The current population of Primeva consists of 14 million inhabitants—including 9 million Primes and 5 million Minions. Even the simple math suggests that it is simply impossible to apply Sponsorship across the board—there simply aren't enough Minion females to go around!

Current count for Minion females in their sexual peak is as follows:



18-34: (14.1% of all female Minions): 359,550 'Sponsorable' Status Minions 35-49: (9.6% of all female Minions): 244,800 'Privilege' Status Minions

Subtracting those female Minions assigned to National Service or contracted to sex work, this leaves a large Prime market for a relatively small female Minion supply. This scarcity has led to the current situation, one in which approximately 205,000 Prime Households (6% of the total 3.42 million Prime households) sponsor a

#### female Minion.

While many have suggested, through exaggerated media reports, that most Sponsors have harems filled with scores of female Minions, the average number of sponsored female Minions per Sponsor

is 1.6—far short of the fantastical claims made, as this chart shows:

#### THE APPLICATION PROCESS

Sponsorship requires enough resources in order to ensure a female Minion is properly managed and maintained. As such, the Sponsorship Application Fee is \$20,000 PD. The so-called 'Red Slip' is non-refundable but does permit access to the MaidenList app, al-



lowing applicants to brows all female Minions currently registered (and available) with the Registry. MaidenList offers a robust search functionality, allowing a user a quick and easy way to discover a Sponsorable meeting their requirements. Current Sponsorships may be renewed for an additional five years (up to the age of 34) for \$10,000 PD. A Sponsor may also choose to go 'inactive' for up to five years for an Inactive Sponsorship Fee of \$5,000 PD.


Once an Application is accepted, a female Minion Sponsorship candidate will be offered. If the Sponsor accepts the Candidate, she will be informed within 24 hours and must present herself to the Sponsor to begin her Sponsorship with 3 days. If the successful Applicant rejects the proposed candidate, their application is automatically resubmitted to the Registry for consideration in the

next Application Review Period. No stigma is assigned to an Applicant who rejects a proposed Candidate, though the Applicant must wait until the next Review Period for consideration of their application.

The typical Application Review Period is quarterly and based on a calendar year. There are four Review Periods in Summer, Fall, Winter and Spring. Once sponsorships have been finalised, a congratulatory list of all Prime Sponsor/s and Minions Sponsoreds is

published in the state media and distributed to all relevant regulatory authorities.

#### THE SPONSOR POINT SYSTEM

Once a Sponsorship Application is lodged, applications are prioritised on the basis of available Minions and the Sponsor Point System. Sponsor Points are awarded per the following schedules:

#### **VETERAN SCHEDULE**

Veterans are awarded Sponsorship points based on seniority and service commendations:

Military Veteran (Enlisted): 10 points Military Veteran (Non-Comm): 20

points

Military Veteran (Jr. Officer): 50 points Military Veteran (Sr. Officer): 100 points

Military Commendation: 5 – 20 points (depending on honour)



#### PARTY SCHEDULE

PRF members are awarded Sponsorship points based on seniority and service commendations:

PRF Central Committee Member: 100

**Points** 

PRF Party Member (prior to Victory

Day): 50 Points

PRF Party Member (post-Victory Day):

10 Points

PRF Party Colours/Orders: 1 – 20 points (depending on honour)



#### **GOVERNMENT SCHEDULE**

Members of the Executive, Provincial, Legislative and Judicial bodies are awarded Sponsorship points based on seniority and service commendations:

Senior Cabinet Member: 200 points Junior Cabinet Member: 150 points

Senior Judge: 100 points Magistrate: 35 points

Province Governor: 200 points

Senator: 100 points

Member of Parliament: 50 points

Civil Service (Senior): 50 points Civil Service (Junior): 25 points

#### PRIVATE SCHEDULE

Members of the private sector may earn Sponsorship points by making voluntary awards to the Treasury:

National Benefactor Award: 200 points (for

\$1 mil PD)

Benefactor of the Revolution Award: 500 points (for \$5 mil PD)

#### NOTABLES SCHEDULE

The Central Committee of the PRF may award Sponsorship points

based on contribution to the nation of Primeva in various fields-- from scientific, artistic, athletic, cultural and other otherwise unspecified endeavours:

Supporter of the Revolution (discretion of Central Committee): 1 - 200 points

NOTE ONE: Sponsorship points may be accumulated from multiple schedules.



NOTE TWO: Prime spouses are allowed to combine their points in jointly submitted Sponsorship Applications. In households in which both spouses have distinguished themselves, this can have a dramatic impact on the success of a Sponsorship Application!

NOTE THREE: If an Application is accepted and a Sponsorship granted, the points required to meet the Grade Threshold (more on this shortly) are 'spent'. Leftover points may be applied to future applications, as can points granted on newly attained achievements or honours.

#### EXAMPLE:

Chacha is a veteran who attained the rank of sergeant (20 points). He was an early PRF member (50 points) and currently serves as a Senior Magistrate (35 points). His wife Thandiwe serves in a junior civil service post in their province (25 points). If they were to lodge a Joint Sponsorship Application, they would be awarded a total of 130 Sponsorship Points.

#### **SPONSORSHIP GRADES**



Female Minions fall into five grades of candidacy value. Though supply ultimately dictates the specific points required to acquire a particular grade, the following are offered to provide a general guide to Sponsorship Point Thresholds required, depending on applications lodged:

GRADE 1- This grade includes those 1st Time Sponsorship Minions, virtually all 18 years of age.

This is the most competitive

tranche in which Applicants compete. Threshold: 200+ points

GRADE 2- This grade includes those female Minions who have satisfactorily satisfied their National Service requirement, and 20+ years of age. Though 'used', the competition for these Minion females is stiff, due to their youth.

Threshold: 175+ points

GRADE 3- This grade includes those 'presponsored' females Minions that are anticipating their 2nd or subsequent Sponsorship, most being in their late twenties and



older These female Minions are most common and in general Sponsorship circulation, due to Sponsors 'trading up'. Threshold: 150 points

GRADE 4- This grade typically encompasses older, less attractive female Minions who have experienced multiple Sponsorships, as well as Early Termination Sponsorships (usually representing a Sponsor rejection based on less than satisfactory behaviour or attitude). They tend to be 30+ and represent the majority of female

Minion 'Sponsorables'. Threshold: 125+ points

Priority List-Priority List Minions are a tiny segment of all 'Sponsorables', numbering less than 1,000 at any given time.

Priority List Minions are assigned based on quarterly judgements rendered by the Priority List Committee. All members of the PL Committee are appointed by the Secretary General, in consultation with the Central Committee. Priority List Minions do not fall under the authority of the Sponsorship Registry Authority.



#### **SPONSOR RIGHTS**

Once an application is accepted, the Prime Sponsor has a wide range of prerogatives they may exercise over their new legal wards, including:

- 1.) Minion Marriage- If a Minion is unmarried, she must request permission from her Sponsor to wed.
- 2.) Childbirth- A Sponsored Minion must receive permission to conceive. Further more, a Sponsor may designate the father of the child, regardless of an existing minion marriage.
- 3.) Marital Relations- A Sponsor may limit, prescribe or otherwise prohibit sexual relations between married Minions.
- 4.) Divorce- A Sponsor may, without cause, unilaterally order the dissolution of a Minion marriage
- 5.) Chastification- A Sponsor may dictate full or part time chastification of his Sponsored. If the Minion is married, they may also chose to place the husband in chastity as well.
- 6.) Sexual services- A Sponsor may demand any sexual service from their Sponsored Minion.
- 7.) Housing- A Minion



applying for housing must have her Sponsor's written permission to do so.

- 8.) Employment- A Minion applying for employment must have her Sponsor's written permission to do so.
- 9.) Travel- A Minion traveling more than ten kilometres beyond her Sponsor's domicile, her workplace or her official address must have her Sponsor's written permission to do so.
- 10.) Recognised medical procedures- If so directed, a Sponsored Minion must undergo any recognised medical procedures designed to enhance her physical appeal, such as cosmetic surgery, as long as said procedure is underwritten by her Sponsor.
- 11.) Early Termination of sponsorship- A Sponsor may terminate the Sponsorship at any time, without cause.
- 12.) Prime Privilege Revocation- Another Prime may not invoke Prime Privilege with a legally Sponsored Minion, under criminal penalty of fines and/or imprisonment.

#### **SPONSORED RIGHTS**

The Minion Sponsored retains some basic privileges, including:

Employment- Sponsor may not interfere in Sponsored's contractual employment or prevent her from employment unless Sponsor is prepared to grant her a Sponsorship Stipend equal to her employment market value (ie. what she would be able to earn in a clerical, industrial or domestic position as determined by the governing bodies in those fields).



1st Night Rights Are You Prepared?

Injury- Sponsor may not permanently scar or injure Sponsored, by accident or by design.

Transference- A Sponsor may not transfer Sponsorship to another Prime.

Investment- A Sponsor is financially liable for any major costs associated with enhancing a Sponsored's appeal.

Criminal- A Sponsor may not coerce the Sponsored into committing criminal or treasonous acts.

### FREQUENTLY ASKED QUESTIONS

May I request a specific Minion?

You may request any Minion currently listed in the MaidenList app.

Am I allowed to use corporal correction on my Minion?

Yes, as long as it doesn't result in permanent scarring or physical injury.

What if a Minion voluntarily requests my personal sponsorship?

A Minion's request carries no weight within the application process.

I had a HIGH likelihood assessment of Application success online but I still haven't had my application accepted. What's going on?

The Sponsorship pool is constantly changing due to circumstances beyond our control. In addition, shifts in national policy may also



impact your application. Please be patient—as long as your application remains logged, you WILL be given all consideration as Minions become available!

Why would I ever have an Inactive Sponsorship?

In order to reward a particularly loyal or pleasing Minion, a Sponsor may effectively 'buy' her Sponsorship by applying for an Inactive Sponsorship, thereby releasing that Minion from any additional sponsorship within the next five years.

My Minion has served me faithfully. Is there any way that I may reward her once her last Sponsorship Period has concluded?

You are entitled to make whatever arrangements you like privately,

whether this involves a straight cash emolument, the purchase of a home or an employment opportunity. Many Minions request a Model Behaviour Exemption from their former Sponsors. This Exemption spares them from Prime Privilege Invocation from the age of 35 to 49, and allows them to concentrate on meeting their Breeding Quota. To apply for a Model Behaviour Exemption for your Sponsored, please complete and return the form



for evaluation to the Sponsorship Registry Authority, Exemptions Department.

I don't like the Minion that has been proposed to me for Sponsorship. What options do I have?

You may reject the Minion but will have to wait for a replacement candidate (if one is available and you still qualify) in the next Application Review Period.

I have overseas holiday plans. May I bring my Minion with me?

No. Minions are not permitted to travel beyond the internationally recognised borders of the People's Republic of Primeva.

What if the Minion proposed doesn't like me or presents negatively towards me?

You may opt for Early Termination, but you will also have to reapply and have additional sufficient Sponsorship Points remaining for an additional application. You may also consider a disciplinary response to her intransigence—eventually all Minions learn to submit (it is in their nature!).

Are there any plans to allow Primes to sponsor male Minions?



There are no such plans at this time.



I am a Prime Lady—am I allowed to apply to sponsor a female Minion?

Yes. You are eligible to apply as a single applicant or in joint application with a Prime spouse. As long as you have accrued Sponsorship Points, you are invited to apply regardless of your gender. In order to achieve their Politics, Culture and Obedience Certification and graduation Secondary School, all Minion females must complete a full academic year of Lesbian Science Studies in order to meet requests such as this!

I have been promoted and must re-locate. How does this affect my

#### Sponsored Minion?

You have 30 days to arrange to re-locate your Minion to the vicinity of your new employment. It is your responsibility to ensure she had equivalent housing. If you intend to have her be unemployed, you must set up a Living Stipend Account, otherwise you must organise a new job for her. In this process, the Minion's new role must be no more than a two steps reduction, according to existing Industrial/Clerical/Domestic Salary Schedules. If Minion is married, you must also arrange for similar employment options for her husband or request a dissolution of the marriage. If the Minion has a child, she will retain responsibility for said minor regardless of decision.



# SPONSORSHIP REGISTRY AUTHORITY RESOURCES

All Sponsorship applicants automatically get access to the Maiden-List application, which is updated in real time by the Sponsorship Registry Authority. MaidenList has listing information on over 100,000 female Minion sponsorship candidates at any given time and is fully searchable by key properties, such as: Location, Age, Cup Size, Hair Colour, Height, Weight, Virginity Status, Marital Status, Employment and more.

Applicants may check their Sponsorship Application Status online at any time, along with a High, Medium or Low assessment of likely application success, based on all current applications logged.

If you feel your application has not been given fair consideration, you may contact the Registry Authority Ombudsman. The Ombudsman will investigate all such concerns and acts as an advocate for the Prime applicant.





#### Who is subject to a Loyalty Audit?

Any Minion resident of any age, at the discretion of a Prime MRC official or a Prime Sponsor of said Minion.

When and where will my Annual Loyalty Audit take place?
You will not be given any prior notification of your Loyalty Audit. Your Audit will take place in your District Ministry of Racial Harmony offices. If you live in a rural area, your Loyalty Audit will be conducted by a Mobile MRH Unit.

#### What happens if I fail my Loyalty Audit?

The adjudicating official may impose a fine, public correction, imprisonment or execution, depending on the degree of disloyalty revealed. A Sponsor may request modifications to the sentence, which are generally confirmed by the MRH official.

#### **SAMPLE QUESTIONS:**

Have you committed any treasonable acts or made treasonous statements?

Have you heard such of such comments or acts and failed to report them?

Have you consumed any media which Minions are legally forbidden to view, listen or read?

Have you had unauthorised sexual activity with another Minion?

Have you made any disrespectful comments regarding your Sponsor in private or in the presence of another Minion?
