I-I LOOK LIKE A BIMBO SECRETARY

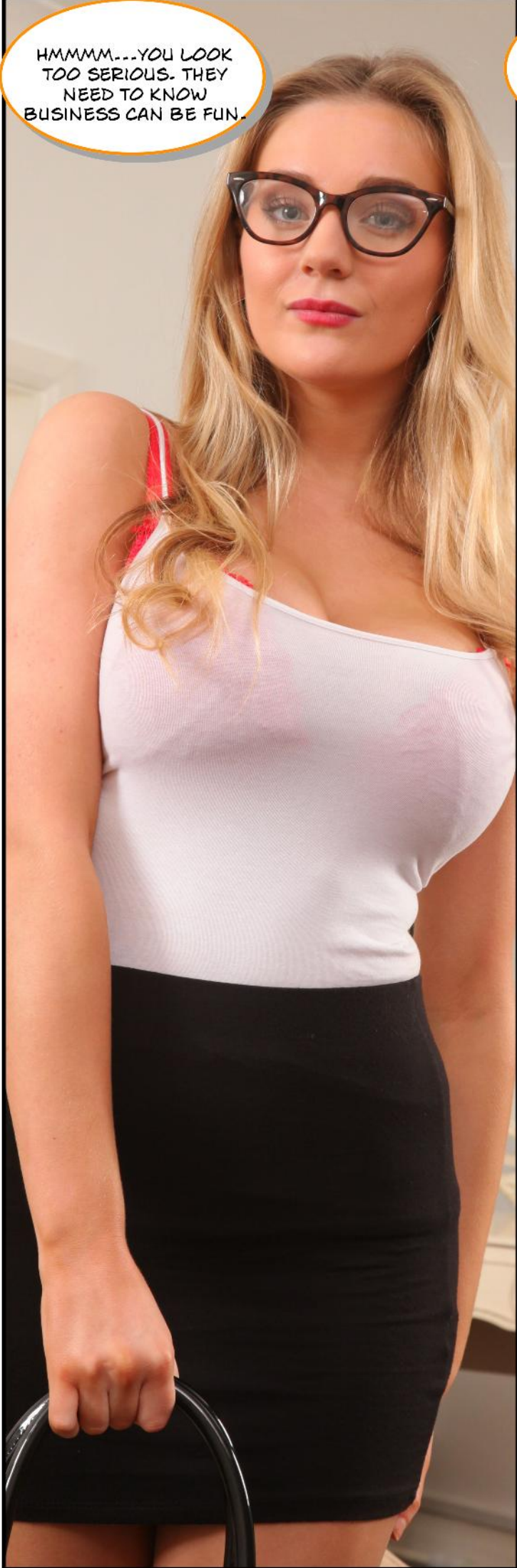
AND IT SUITS YOU. NOW NO MORE OF THIS, LETS SEE YOU PRACTICE YOUR TALK.

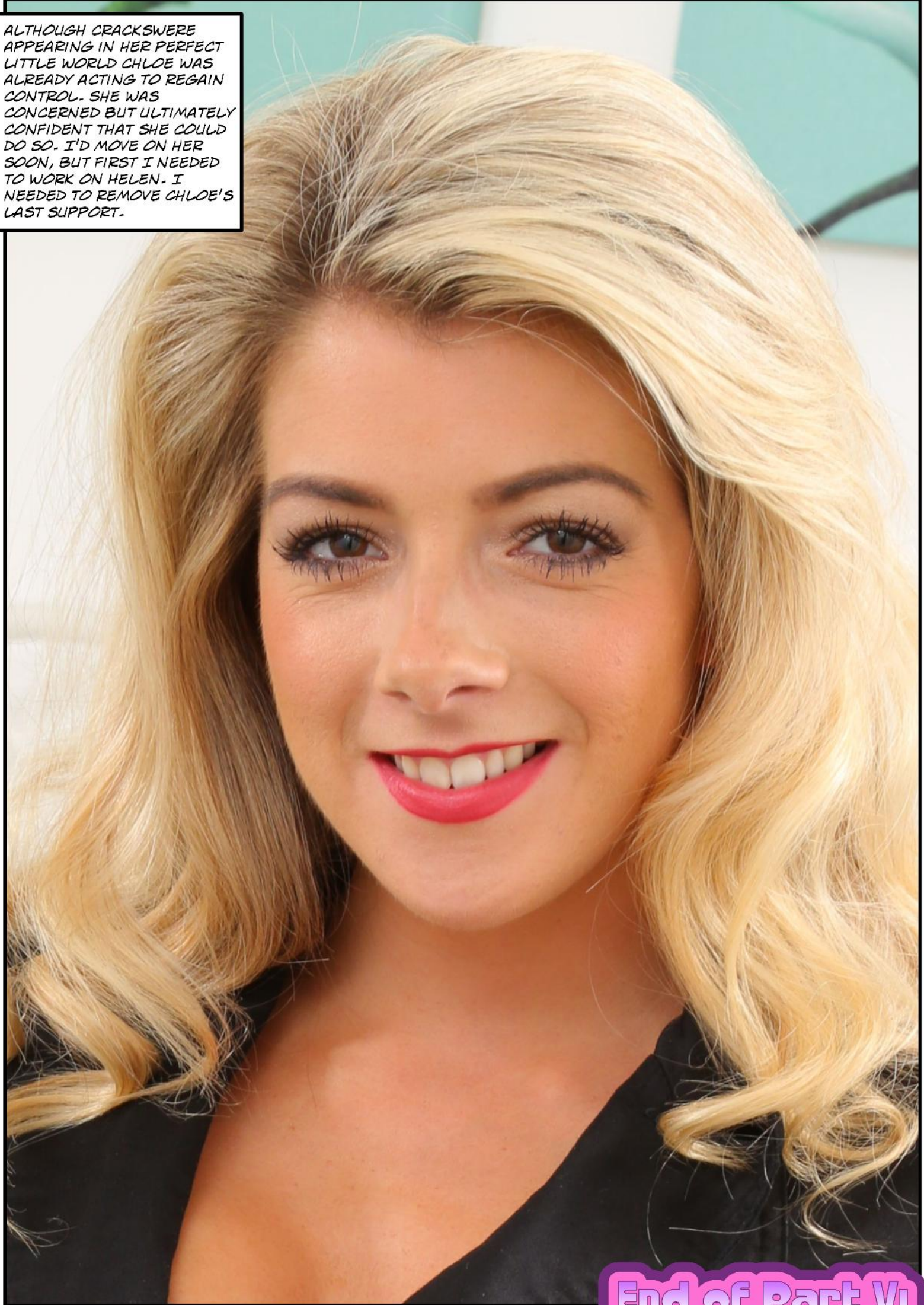


I THINK I COULD HANDLE THIS ON MY OWN, REPORT DIRECTLY TO YOL PERHAPS?
