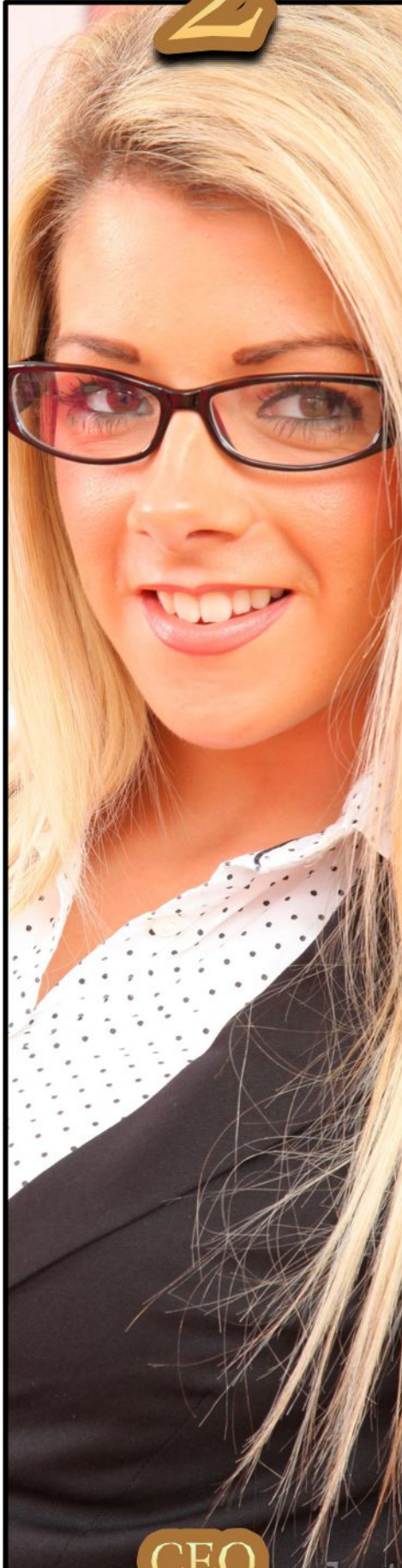

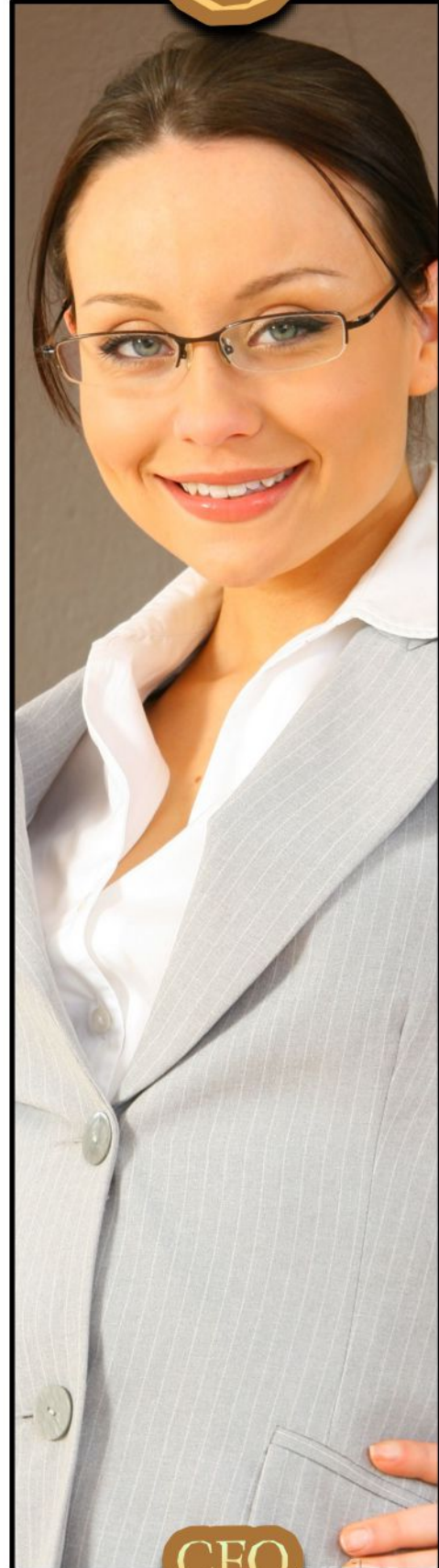

GETTING QUITE URGENT.




A few minutes later

LOOK DIFFERENT.

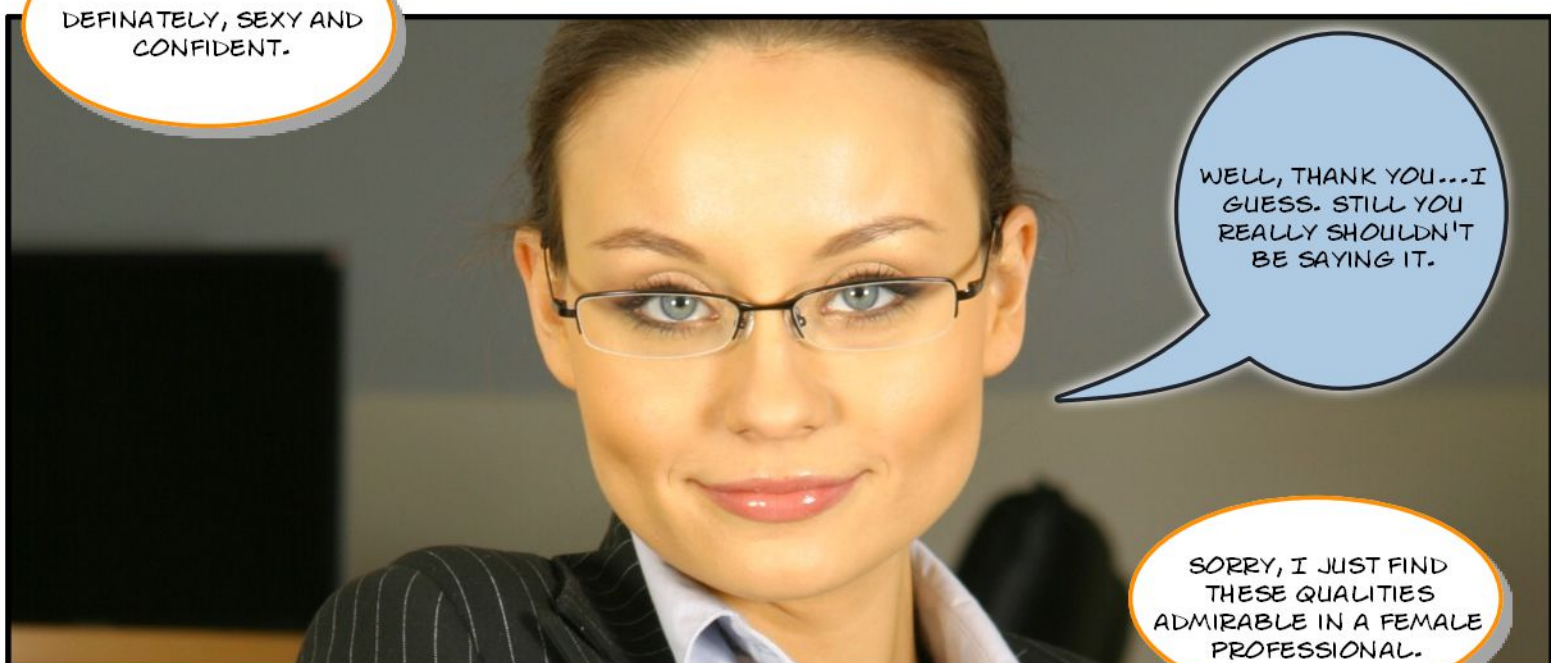
D-DIFFERENT? HOW?

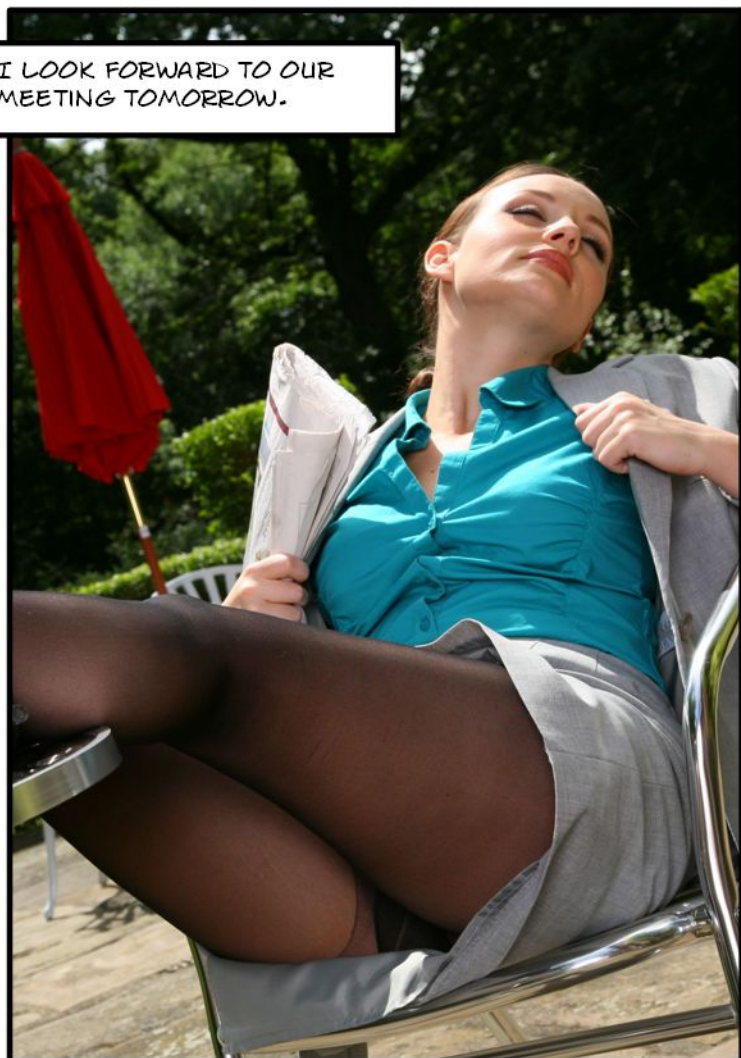
Helen at Home

I FEEL LIKE I AM BEING WATCHED. SOMETIMES I THINK I HEAR VOICES.


VOICES? PERHAPS FROM THE OTHER APARTMENTS?
